## MGMA BOARD UPDATE December 2017

In December we had the Annual Membership Meeting at which we did not have a quorum (a quorum at a membership meeting either in person or by proxy is 10% of the total voting interests of members), therefore, the Board from 2017 rolled over to 2018.

Some of the completed items for 2017 included, completion of the MGMA Village redeeding, sidewalk cleaning, and modifying the landscaping on Crestwood Blvd median and the island at the front entrance of Okeechobee and Crestwood Blvd.
