### Virtual Council Regular Meeting was called to order at 6:30 p.m.

**Thursday, August 20, 2020**

#### **The following action was taken:**

- Approved Fifth Addendum to Independent Contractor Agreement for Early Childhood Adventures, LLC for additional early childhood educational programs.
- Approved Fifth Addendum to the Law Enforcement Service Agreement with PBSO.
- Approved agreement with Property Works in an amount of \$48,878.56 for Parks Maintenance Service.
- Approved First Addendum to the Food and Beverage Services Agreement with Sweetcravings Café, LLC to January 1, 2021 or whenever Commons Park opens at full capacity.
- Approved Site Plan Modification and Architectural Approval for 1.56 acres located on the northwest corner of Southern Blvd. and Cypress Head Ave.
- Approved Final Plat for Crestwood North Replat
- Adopted Ord.1003 seeking a change of land use designation for 4 parcels of land located 850 ft north of Okeechobee Blvd. and 500 ft west of Royal Palm Beach Blvd.
- Adopted Ord. 1002 to allow Electric Vehicle Charging Stations as accessory uses in certain zoning districts.
- Adopted Ord. 1001 amending Chapter 26 to allow adult day care centers as a permitted use in CG— General Commercial Zoning District.
- Adopted Ord. 1004 amending Chapter 20 in order to increase the size limitation for freestanding monument signs on Village-owned property.

- Approved first reading of Ord. 1005 amending Chapter 17 to modify the hours of operation for public parks within the Village to be consistent with existing policies and procedures.
- Approved conceptual design #2 for the Southern Blvd. and Royal Palm Beach Blvd. intersection entry feature.
- Appointed Brittany Lee as a regular member and DK Nelson as an alternate member to the Education Advisory Board.
- Reappointed William Nuss to serve on the PBC Water Utilities Advisory Board.

### Virtual First Public Budget Hearing was called to order at 6:30 p.m.

**Tuesday, September 8, 2020**

- Announced proposed operating millage rate to fund budget is 4.97% above the rolled-back rate of 1.8291mils.
- Announced proposed operating millage rate is 1.9200 for the General Fund.
- Adoption of proposed operating millage rate of 1.9200 for FY2020/2021 and Tentative Budget for FY2020/2021.
- Announced Final Budget Public Hearing-Thursday, September 17, 2020 at 6:30 p.m.

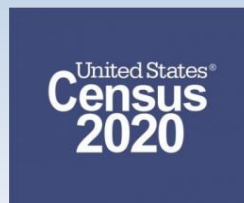
