**12. New Business –**

- **Tree Trimming Approval** – Mrs. Loomis stated that it's the time for the annual palm tree trimming and requested approval to have our landscaper, Riquelme, trim all of the palm trees in the amount of \$29,400. Mr. Garramone made a motion to approve the annual palm tree trimming with our landscaper Riquelme in the amount of \$29,400. Motion seconded by Mr. Gardner and unanimously approved.
- **ARC Committee Member Changes** – Mr. Larsen advised that there have been recent changes to the ARC Committee, with some members stepping down and new members being appointed. The changes are as follows: Steven Rademacher and Gwendolyn Price be added as new members of the ARC Committee. Ana Vargas will rotate off the committee. Steve Marionakis will transition to an alternate position. Patricia McCarthy will no longer serve as an alternate and will be removed from that role. Mildred Colon will remain as the second alternate. Martha Haberman will remain on the committee and be appointed as head of the committee. The Board thanked the committee members for their volunteer service to the association. Mrs. Diasio made a motion to approve the new changes to the ARC committee. Motion seconded by Mr. Gardner and unanimously approved.
- **Ratify Clubhouse Heater** – Mrs. Loomis stated a motion is needed to ratify the emergency vote to replace the clubhouse heater that was no longer functioning. The original quote for replacing the heating element was \$2,386.22. She was able to negotiate a better price of \$875 with Comfort Zone. Mr. Garramone made a motion to hire Comfort Zone to replace the clubhouse heater in the amount of \$875. Motion seconded by Mr. Gardner and unanimously approved.
- **Tennis & Basketball Resurfacing & Repair** – Mrs. Loomis stated that the basketball and tennis courts are due for repair and resurfacing this year, a process that occurs approximately every 6-7 years. She received two quotes and recommended hiring **Armor Courts** for this project. Their pricing is the most competitive, and their proposal was the most inclusive to help preserve the aesthetic appeal of the courts. Mr. Axelberd made a motion to hire Armor Courts to repair and resurface the basketball and tennis courts in the amount of \$53,348.00. Motion seconded by Mr. Garramone and unanimously approved.
- **Open Forum** – The residents were given the opportunity to speak in the meeting.  
**Adjournment** – Mr. Axelberd made a motion to adjourn the meeting at 7:27 p.m. Mr. Garramone seconded the motion, and it was unanimously approved.
